If any of the following occur during the time you are being investigated, you **must** notify the Administrative Sergeant of Professional Standards and Training in writing:

- Name change
- Address or telephone number change.
- Employer change
- If you are arrested.
- If you receive a criminal summons.
- If you are sued.
- If you receive a traffic citation.
- If you become the subject of a disciplinary action at work.
- If you are terminated from any employment.
- Any other significant event that may occur in your life.
